

# CEA-HOW, Inc. Treasurer's Report World Service Business Conference and Board Meeting July 2024

#### Six Months Ending June 2024 vs 2023 – Executive Summary

For the first six months (January – June) of 2024, CEA-HOW, Inc. generated a net loss of \$244 vs. a net loss of \$5,369 in the comparable period in 2023, for a net improvement of \$5,125 year-over-year. Importantly, however, this year's net income result included a very generous single donation of \$10,000 in the first quarter. Treating this as a one-time occurrence, normalized net loss YTD 2024 would have been \$10,244, essentially doubling the net loss for the same period in 2023.

Gross income (inflows) was \$74,696 through June of 2024, for a 22% improvement over the equivalent period in 2023. Normalized gross income (again, excluding the one-time \$10,000 contribution) was \$64,696, representing a 6% improvement over 2023.

Expenses (outflows) YTD 2024 were \$74,940 versus \$66,497 for the first half of 2023, representing a 13% increase.

Our organization's profit/loss is predominantly driven by contributions, representing 84% of gross income, offset by operational expenses, representing 92% of total expenses. Literature sales and the conference/convention both generate a modest profit over the course of a full year.

Operational expenses consist primarily of payroll and rent for a minimal part-time office staff in a modest footprint of sub-prime office space, respectively, to support the organization. Operational expenses are up 16% year-over-year, due to previously detailed payroll increases, long overdue and necessary to catch up to inflation and retain qualified talent. Operational expenses are largely fixed.

In contrast, contributions are almost entirely variable. Contributions were up 38% for the period ending June 2024, or 16% on normalized basis excluding the one-time \$10,000 contribution. Contributions are not quite keeping up with – nor offsetting – operational expenses. As such, while we celebrate the tremendous individual benevolence this year, we urge the fellowship as a whole to continue to focus on building our 7<sup>th</sup> tradition momentum so that we can invest in the Program offerings and broaden the reach to the compulsive eater who still suffers.

Notwithstanding the need for increased collective contributions to sustain and build the Program, we are in solid financial position. As of June 30, 2024, CEA-HOW, Inc. had \$265,296 in assets, including \$67,318 in prudent reserves per policy, and \$233,718 in total cash and equivalents.

**Literature:** Literature purchases in the period were approximately 29% down vs. the comparable period in 2023. This decline was principally attributable to printed literature, with decreases in both English and Spanish literature sales.
